Request for Technical Review Assistance for the Remedial Investi-

gation and Feasibility Study (FI/FS) for the Atlas Asbestos Mine

The Environmental Protection Agency (EPA) Region IX is currently preparing documents for a RI/FS for the Super Fund listed Atlas Asbestos Mine. This mine is located in our Hollister Resource Area, Bakersfield District in southwestern Fresno County. EPA has established very tight deadlines for review of documents associated with the RI/FS. Unfortunately, the expertise required to afford these products adequate review is limited here in the state and outside capability, i.e., contracting is limited by the schedule developed by EPA. It is essential that we afford these products timely and credible review and comment. This entire issue has nationwide implications regarding Bureau management, 3809 surface mining regulations, and the 1872 Mining Law.

On February 25, 1988, a briefing on this issue was conducted by Bakersfield District Staff for D-471, D-474, and D-150 at the Service Center. The purpose of this meeting was to explore the possibility of obtaining technical review assistance for the EPA generated documents for the Atlas Asbestos Mine FI/FS. The following is a schedule developed during that session and modified based on subsequent telephone conversations between Dave Howell (AM, Hollister RA) and Bruce Van Haveren (D-474).
